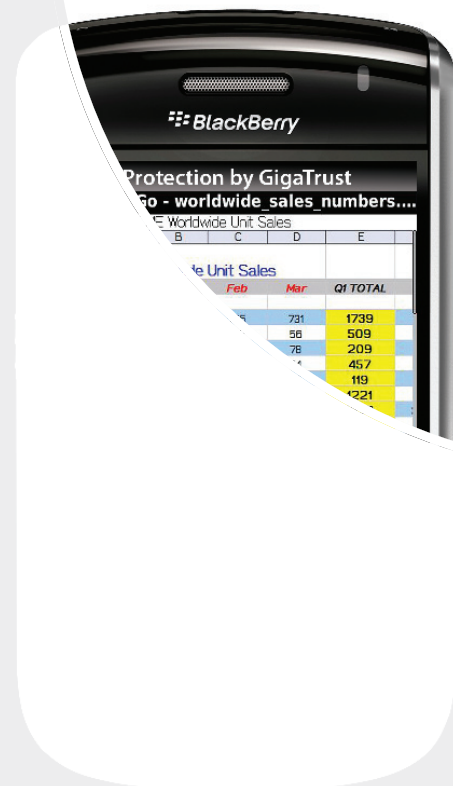

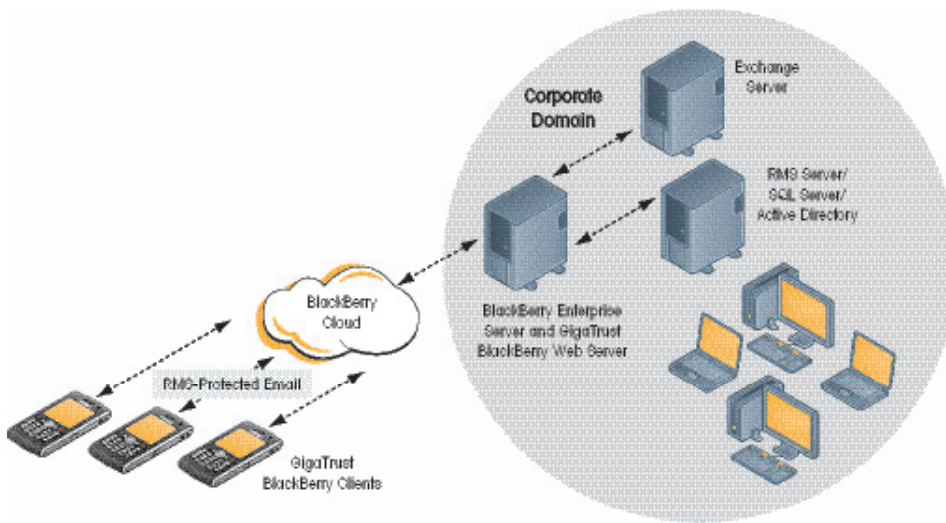

Improve information sharing by providing access to protected content on mobile devices

If email permissions allow forwarding, attachments remain protected whether they are accessed on a desktop or on a BlackBerry. GigaTrust is the only Microsoft Partner to bring this level of secure interoperability between RMS and your BlackBerry deployment (see Figure 1).

Viewing and protecting content via GigaTrust for BlackBerry
